**Re: Pre-Qualification No. 589/2025 – Invitation to Pre-Qualify with respect to  
Participation in Future Tenders for the Execution of Infra #1 Works of the Tel Aviv  
Metropolitan Metro Lines (the “Invitation”)**

**Notice regarding Participants’ Conference and Face to Face Meetings (“Notice”)**

**Participants’ Conference**

1. Pursuant to Section 2.13 (Participants’ Conference) of the Invitation, and subject to the following, the Tender Committee hereby invites Entities from Israel and abroad to attend a three-day Conference.
2. The Conference will take place from the 23<sup>rd</sup> to 25<sup>th</sup> of February 2026.
3. **Day 1 (February 23<sup>rd</sup>, 2026).** The first day of the Conference will feature a guided tour of a segment of the planned Network route, including a visit to one of the underground stations of the fully operational Red Line of the Tel Aviv metropolitan light rail system. During the tour, NTA will present key elements of the Network’s design and implementation and highlight selected engineering challenges. In the evening, a gala event will be held at the Hilton Hotel in Tel Aviv.
4. **Day 2 (February 24<sup>th</sup>, 2026).** The second day of the Conference will be held in its entirety at the Hilton Hotel in Tel Aviv. The morning session will be dedicated to a presentation of the Project by NTA. Following lunch, NTA will conduct individual face-to-face meetings with prospective Participants who requested to participate in such meetings as part of their Application (as defined below). These meetings are intended to enable prospective Participants to raise and discuss issues they consider fundamental to their participation in the Pre-Qualification Process and the Tender Process.
5. **Day 3 (February 25<sup>th</sup>, 2026).** The third and final day of the Conference will take place at a location to be determined (which will be notified to the Participants at a later stage). NTA will continue the face-to-face meetings while also hosting lectures on various topics, with a particular focus on working and conducting business in Israel, and additional related matters.

### **General Provisions regarding the Conference**

6. Attendance at the Conference is limited to five (5) individuals on behalf of each Entity and is subject to prior registration as specified below.
7. Entities who wish to participate in the Conference are required to submit an application (“**Application**”) by filling in the e-form in the following address: [submit here](#). Applications must be submitted by no later than January 24<sup>th</sup>, 2026. Applications submitted after the foregoing date may be accepted or rejected, at the discretion of the Tender Committee.
8. Additional specifics with respect to the Conference, including the time slot for the face-to-face meeting and the applicable procedures and preconditions (including the prior submission of Requests for Clarifications) with respect thereto, will be provided separately to Entities whose Application was accepted.
9. The Conference is intended for prospective Participants (i.e., contractors) and not for the general public. The Tender Committee reserves the right to reject an Application submitted by an Entity which is not a prospective Participant (including, *inter alia*, Applications submitted by consulting firms, design firms, engineering firms, project management firms, etc.). The foregoing does not derogate from NTA’s right to invite additional parties to participate in certain parts of the Conference.
10. Attendance in the Conference shall not be regarded as a requirement for the submission of a Pre-Qualification Submission.
11. The provisions of Section 2.13 (Participants’ Conference) of the Invitation shall apply to the Conference.

### **General**

12. **Tender Committee’s Rights.** The issuance of this Notice does not derogate from any of NTA’s or the Tender Committee’s rights and prerogatives under the Pre-Qualification Documents or Law.
13. Without derogating from the generality of the foregoing, the Tender Committee reserves the right to modify or update any aspect of the Conference, including dates, time schedules, durations and procedures, at its discretion.
14. Capitalized terms not otherwise defined herein shall have the meaning ascribed thereto in the Tender Documents.
