**For the Execution of Development and Utilities Relocation Works at Levi Eshkol Avenue, Holon, Holon Intersection and Ben Tzvi Road in Tel Aviv-Jaffa - section G1 (sub-section G1-7) of the LRT Green Line Project**

1. NTA - Metropolitan Mass Transit System Ltd. ("NTA") hereby invites Bidders to participate in a public tender for execution of development and utilities relocation works at Levi Eshkol Avenue, Holon, Holon Intersection and Ben Tzvi Road in Tel Aviv-Jaffa - section G1 (sub-section G1-7) of the LRT green line Project (the "**Tender**"), All as specified in the Tender documents.

7. The Submission Date of the Bids is **no later than 18.2.2021 at 13:00 PM**. The Bids shall be deposited in the designated Tender box located at NTA's offices, Harokmim 26 Holon, building A, 9th floor. All Bidders shall be responsible for receiving confirmation of their Bid submission.
8. Within the Tender frame an evaluation of the contract value shall be edited (i.e. "אומדן שווי התקשרות") as such term is defined in the Mandatory Tenders Regulations, 5753-1993.

The Bidders are fully responsible to carefully review the Tender Documents in their entirety.
